Trustees are recruited and appointed in accordance with the Policy, Organisation & Rules ("POR") of the Scout Association.

Activities & Achievements

Following the return of Face to Face Scouting in May 2021, the Scout Group has consolidated its position and is now offering more Camping and activities to young people in the Area. The demand for Scouting in general is huge and demand far outstrips supply. At the time of census January 2022 we had 54 young people of Beaver Age and above on our waiting list. Now (Oct 2022) we have 81.Our Scouts and Explorers. Our young people in the Scouts and Explorers took part in a lot of camping, and outdoor activities and 996 badges were gained by our young people.

Reserves Policy

The Trustees believe that around 3 months of annual expenditure is an appropriate level of reserves in order to cover the timing differences between receipts and payments and to allow for any unexpected expenditure, such as the cancellation of Camps and Outings, and unexpected maintenance on the Scout Hall.

I report on the financial statements of the 14th Midlothian Bonnyrigg Scout Group ("the Group") for the year ended 31st March 2022 which are set out on pages 3 to 5

Respective responsibilities of Trustees and Examiner
